- CCCIJ Member **KAZELFA** (represents Elmarco s.r.o.) exhibited at **Battery Japan 2019**




03/2019



- CCCIJ with support of Embassy of the Czech Republic in Tokyo joined the project to support Czech economic activities abroad (**project PROPEA**).


